1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government Maa Mahamaya College Khadgawan, Dist- Manendragarh-Chirimiri-Bharatpur, Chhattisgarh is an emerging educational institute in the field of higher education in this tribal area. It was established by Department of Higher Education Government of Chhattisgarh in the year 2010 as Government Naveen College, Khadgawan. Initially the institute started operation from Old Janpad Panchayat building Khadgawan. On 20th of Oct. 2015 it was shifted to its own new building conferred upon by Government of Chhattisgarh. Since then the number of students is increasing year by year and real stack holders are being benefitted with basic facilities and favorable academic atmosphere.

The Department of Higher Education, Government of Chhattisgarh changed the name of the college in 2018 as Government Maa Mahamaya College Khadgawan Dist. Korea Chhattisgarh with permanent affiliation with Sant Gahira Guru Vishwavidyalaya, Sarguja Ambikapur (C.G.) availing the faculties of Arts, Commerce and Science up to U.G. and one P.G. (M.A. Hindi). The institute is registered under 2(f) as per UGC guidelines. The NSS unit of 100 students is also active at our college. The Janbhagidari Committee is formed under the guidance of Government of Chhattisgarh for the development of the college with association of local inhabitants. Various Committee are formed for the successful working of the institute.

HISTORICAL BACKGROUND

Block Khadgawan is located on the state highway No. 08 (Bilaspur – Chirimiri) surrounded with the natural greenery and abounds in the natural black diamond. The college is named after the historical SHAKTI PEETH of the deity MAA MAHAMAYA. The block is divided by the great river of Chhattisgarh named Hasdeo river that has its origin from Sonhat block of Dist. Korea.

- To develop the spirit of liberty, equality and fraternity among students and make them aware of nature and human rights.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- The institute has the building of its own situated just behind to the higher secondary school Khadgawan on the state highway 08 and it is easily accessible for the students coming from the remote places.
- The new college building is encompassed with natural and lush vista of Nature that creates positivity in the students' minds. It is duly well-fenced with five (05) staff quarters, canteen building and the facility of parking the vehicles.
- The institute offers UG programs for the faculties of Arts, Science and Commerce i.e. B.A with Foundation Course, English Literature, Hindi Literature, Political Science, Sociology, Geography, B.Sc. with Foundation Course, Chemistry, Botany and Zoology and B.Com with all compulsory subjects and one P.G. program with M.A.(Hindi) with compulsory subjects.
- The college accentuates on the over-all personality development of the students with the exposure to extra co-curricular activities.
- The college library is quite spacious for the smooth browsing of the books for the students. It has flourishing and very informative collection of around 8000 course books and references.
- The Campus is supervised by CCTV Surveillance system for the protection all around.
- The college have 100 students NSS Unit and the Swayam Sevaks work hard and bring laurels to institute.
- The college has two (02) regular assistant professors with (01) having Ph.D. and (01) having M.Phil. degree from there owned university boosting for the academic atmosphere and the conduction of seminars, webinars, etc. The guest lecturers are also very well educated some of them having NET imparting knowledge in the respective subjects. Even the non-teaching staff members are highly qualified having SET certificate helping students.

- We have more than 75% of the students getting scholarship that is very helping to the students living below poverty line belonging to the rural and agricultural background.
- Students actively take part in various activities like games and sports, cultural programs and inter college competition thereby displaying their calibers.

Institutional Weakness

- The college lacks modernized lab, computerized and well equipped smart classes, auditorium, separate building for library, staff quarter as per the sanctioned posts, playground, hostels etc.
- The institute needs more infrastructures for future as the new PG programs are sure to be opened at the college
- Lack of promotional scope for research work.
- Out of 10 Asst. Professor and 01 Professor there are 02 regular posts of the assistant professors and the permanent posting of the regular principal are kept vacant since the establishment of the college that is creating entirely unfavorable effects in the academic process.
- Due to non-acceptance of the post of librarian and sports officer in the college, their establishment could not be done in the college.
- Due to vacant posts, faculty members get overburdened that badly affects the performance of the present staff members and learning outcome of the students.
- Lack of funds for the smart classes and smart labs.
- Lack of transport facility for the students since they come to attend classes 50km away from the college.

Institutional Opportunity

- The department of Botany draws the attention for the research work since the college campus is surrounded with many rare plants and herbs. Moreover the Khadgawan zone and the location of the institute is purely agricultural so the strong possibility for the enrichment of the very field with PG program is need of the hour.
- Provisions of PG programs would be great opportunity for the students of the tribal area.
- Competitive skills and improvement of the soft skills for employability of the students need to be developed making them more efficient for the job opportunity.
- As the Government of Chhattisgarh confers scholarship to the SC, ST, OBC, and meritorious students, the faculty members have great opportunity by boosting the morale of the students to achieve new height of their respective choices.
- The conduction of the national and international conferences, webinars on the available subjects has great possibilities for our graduates as it opens before their minds the new and job securing mental abilities.
- The new academic blocks and the facility of the hostels would be more encouraging for the forthcoming aspiring students.
- Active participation of alumni.
- Academic opportunities are multiplied with collaboration and strengthening MOU with neighboring educational institutes.

Institutional Challenge

- More than 80% of the stakeholders of the institute are economically weaker and from rural background providing a parallel, positive and equated platform and freeing their respective minds from inadequate fearful suppression and reluctance to further their progression in higher studies is quite challenging.
- After devastating the negative effects of Covid-19, bringing our students in the strenuous and hardworking streamline is very demanding.
- Availability of the basic fulfillment of the staff, enhancing the faculties, E-academic dealings enriching the library online and offline systematization is urgently needful.
- Having Hindi medium background, students face great hardships to cope with requirements of higher studies which is provided purely in English medium.
- Big difference in percentage academically as per the urban and rural areas facilities is concerned.
- Less number of selection and placement of alumni and recently pass out students in the reputed sectors, i.e. bank, railway, army, navy, air force and other sectors of Govt. of India is really disheartening and the motivation is highly demanded.
- Lack of proper transportation bars the students to maintain the stipulated presence at the college.

Teaching-learning and Evaluation

The institute has strictly been following the academic calendar well-structured by the Department of Higher Education, Government of Chhattisgarh and Sant Gahira Guru Vishwavidyalaya, Sarguja Ambikapur (C.G.). The activities of entire academic session such as admission process is performed as per the rules of Government of Chhattisgarh strictly following the Reservation policy for all the categories, internal tests and evaluation, holidays and vacations, formation of students' union, conduction of examinations, important dates of games, cultural programs and extra co-curricular activities are well covered by it.

Apart from that the institute plans its own academic calendar with necessary inclusion of completion of course in prescribed durations, teaching plans, methods to attain Po, Pso, and Co, unit tests, arrangement of regular classes, practical classes and all the scheduled activities as ordered by the Department of Higher Education (C.G.).

The regular faculty members along with the guest lecturers have been making use of the innovative technologies for imparting knowledge to the students. The students can freely ask questions and some of the sharp minded students are given the liberty to present themselves with the selected topic on the green board. Through group discussion, quizzes and tests and participative teaching, students are engaged in the concerned subjects. The Academic Administrative Audit / the internal exam committee is operational for monitoring all the process and keeping the records accordingly,

The program outcomes, program specific outcomes and course outcomes are vividly displayed in the institutional website as in college campus.

Research, Innovations and Extension

The institute always encourages our staff members and students for the active participation in understanding the worth of research activities, the significance of innovation and the value of extension activities. The culture to re-search has always been encouraged by the college and th young faculties are participating in conferences and workshops. Recently the institute conducted a seminar and the webinar in gender and the environmental issues in which all the staff members and the many students showed their presence and got benefitted with it.

Our institute has one faculty with assistant professors having Ph.D in Political Science. He is also becoming research guides by Sant Gahira Guru Vishwavidyalaya, Sarguja Ambikapur (C.G.). Our regular staff members have been continuously publishing research papers in the peer-reviewed journals for past five years. We have had the invitations from the different colleges to deliver the papers showing the worth of the research activities as such endeavor demands the effort of this sort.

As the college has the operational unit of NSS with 100 active students that extends such activities as

Traffic awareness, Environmental awareness, programs for cleanliness, Campaign for plastic free campus, Blood donation, Awareness for diseases, oath taking on National Voters' Day making the students aware for the electoral procedures, planting the young sapling on every World Environment Day.

Infrastructure and Learning Resources

Our institute has been shifted to the new building since 2015 and the total constructed area is 1454 square meter surrounded with 14.57 acres of land under its own possession. The college has self-occupied duly fenced area with a canteen building and 05 staff quarters. There is a parking stand for the staff members and the students. It has the electric transformer of its own for the separate use of the institute. The college campus is under CCTV surveillance with 16 cameras to ensure comprehensive security of the whole campus. The college has a fire safety unit for the safety purpose. The College has underground rainwater harvesting system and varmi compost tank. There are four toilets cum attached bathrooms for boys and girls and male and female staff members. There are 27 rooms in the college building, 10 of them are separately meant for the completion of three years' B.A. B.SC. B.COM. programs and M.A. Hindi.

The college has two bigger rooms for the office and the principal. There are separate laboratories with

adequate lab materials, for Chemistry, Botany, Zoology and Geography. The college has the separate hall for library and the conference hall for the sake of deliverance of special programs, seminars etc. There are around 8000 course books and refresher books are available in the college library. Extra rooms are used for the purpose of NSS unit, games and for other essentials. College also have one girls common room with sanitary pad machine used for all female staff and girls of college. The college has a cultural committee which motivates students to participate in cultural and others events like , rangoli, drawing, painting, dance, Mehandi, song etc.

Student Support and Progression

Students' being the key stakeholder of the system, the institution exhibits proactive concern for the progress of its students and supports them in all their endeavors. It has well-established mechanism for student-support services, mentoring and progression, complemented by good faculty leadership and broad-based institutional commitment. Students belonging to reserved categories and lower income groups are facilitated to receive several scholarships provided by the Government.

The institute and all the staff members whole heartedly support our physically present stakeholders and newly admitted students on merit basis for their future progression and betterment. To meet this moral and administrative liabilities more than 20 committees and some important cells have been formed. Committees like Anti-ragging committee, SC,ST,OBC, and Minority committee, Public participation Committee, Grievance and Sexual harassment Redress Cell, Career Counseling cell are specially constituted for the welfare of the students. The college plans to avail an extended brochure with relevant information concerning admission and all the annual happenings on the campus. Although the general information are duly posted in the website of the college but the initial stage the newly admitted students are induced and acquainted with features of the college.

The fulfillment of the social and domestic expectations is achieved by NSS through various activities for the awareness of social responsibilities, helping the poor and diseased people, donating blood, giving directions for

the stress management. As per the rules and regulations of Government of Chhattisgarh, students belonging to SC, ST, OBC, are provided scholarship, free books and the stationeries. The problems of the girls are dealt actively by Grievance and Sexual harassment Redress Cell that organizes and pinpoints the women related issues making their minds ethically strengthened. Moreover availability of books in the central library through the book bank . SC/ST. BPL scheme greatly benefit the students in this regard too.Since the establishment of the college the number of students has consistently been increasing. AfterGraduating from the institute the alumni visit their alma mater sharing their present academic progressions and giving suggestion for the betterment of the college.

It is quite encouraging that most of them are preparing for UGC-NET or preparing for Civil Services. Their body language and over all gestures produce the soothing feeling in the staff members.

Students enthusiastically take part in various sports and cultural activities as directed in the academic calendar provided by the university. Presently the process of nominating the office bearer in the vogue so the members of the students council direct all the personality developing activities in the college. Students' satisfaction and their wellbeing in all respects have been brooded upon, discussed and logically implemented by the institute.

Governance, Leadership and Management

The department of higher education, Government of Chhattisgarh has the sole power to govern all the higher educational institutes across the state. Since our college comes under the public sector and it is the government institution so all the rules and regulations are laid down by state government, affiliating university, UGC guidelines and the orders by MOE, Government of India. For the sake of the transparent dealing of the college, E-mechanism has been successfully used particularly for finance, admission, examination and the students support. All the financial transactions are audited by the Chartered Accountant and minutely monitored and well observed by IQAC along with collecting the feedbacks from the students.

To achieve the annual goals, the committees formed by the Principal play very vital role as all the staff

members, are actively engaged in participative management. Being the head of the college the Principal has the responsibilities for administration, financial transactions, academic activities and the extending such activities for betterment of the college. He is assisted by the coordinator of the departments, librarian, sports and NSS officer and the members of public participation committee (Janbhagidari Committee). All in all the functioning committees work hard for the development of the college. Finally the principal conducts a meeting with Teachers to discuss the student's performance and necessary action plan for further improvement. The Teachers also evaluate students through the practice make to solve previous year question papers. The students are the important stakeholders in any institution imparting education and it is our endeavor makes all efforts to ensure transparency in all the assessment at different stages. Taking this spirit into consideration the College deals with examination related grievances transparently, efficiently and in a timely manner.

Internal Examination related Grievances- The teaching-learning, assessment process in the College is transparent. To ensure the transparency in internal examination, guidelines of exam are displayed on notice board, College website and circulate in the class rooms. The internal grievances related to Class tests/Unit tests, Practical and Project works etc. are resolved by Assessment Grievance Redressal Committee in consultation with respective teaching Staff. The students have free access to the subject teachers regarding any discrepancy or grievance. Answer sheets provided to the students and if there is any objection in marks by the student is redressed immediately.

External Examination related Grievances- The Annual exam related grievances come under jurisdiction of university. Any grievances related to the external evaluation are being addressed at university level through a special Grievance Redressal Committee constituted by the university for this purpose. To avoid

grievances, the College circulates and display notice regarding registration of exam form, admits card, dates of exams, etc. in classrooms, notice boards as well as in the College website respectively. After the declaration of results the university notifies the deadline of 15 days to apply for the verification, revaluation and photo copy of answer sheet. Accordingly the students can apply with their grievances to the university. There is a provision for revaluation of the answer sheets. Evaluation determines the extent to which a Programs and Courses achieves predetermined Outcomes or Goals. The Govt. Maa Mahamaya college Khadgawan, evaluates through various methods to measure the attainment of program-specific, course outcomes by taking Unit tests, half-yearly and pre-final examinations are taken according to the academic calendar provided by the Higher Education of Chhattisgarh. These funds are used in Salary of all employes and the maintenance of Infrastructure like -Furniture ,Electricity,Telephone,Sports Products,Laboratory Appratus and Raw materials,Information Technology related materials,Books and Stationary for library and Reserved Category Students .

Non-Government Funds:

As non-Government Funds, fees taken from newly admitted students under AF head - Student Union, Sports, Literary Activity, Letter and Magazine, Reserve, Development Fund Reading Room, Cultural Activity, Principal Vivek, Saraswati Puja etc. are collected along with Under the non-government item, under the PD item, fees are charged - bicycle stand, identity card, physical welfare, university library, student welfare, youth activity etc.

Janbhagidari Funds:

In addition to this there is corpus of fund collected from the enrolled students known as Janbhagidari fund. The Janbhagidari funds are utilized in the maintenance of infrastructure, salary of temporary staff and in respective requirements.

The amount received from government, non-government and janbhagidari items is spent on various items as per requirement through the Principal (DDO) of the college by inviting tenders through the purchase committee formed at the college level following the rules of Chhattisgarh Government Store Purchase Rules 2002 and amended 2022. This is done through the Principal and the amounts are paid to the concerned firms through online medium through treasury and partly in cash.

The Principal of the College authorized as the Drawing and Disbursing Officer (DDO), monitors and supervises the sanction funds and ensures its utilization. The optimal utilization of the financial resources is made after completion of all procedure and policies like; submission of proposal, consultation with the Purchase Committee/concerned department, sought quotations and approval of the Principal and purchase committee, supply Order given to the vendor for purchase of needs-cum-requirements. The funds generated are mainly utilized for development of infrastructure and its maintenance, for upgradation of library and laboratories, strengthen in technology capacity etc.

The College has conducted Government and Janbhagidari Financial Audits at the end of each academic year.

Being a Government institution Govt. Maa Mahamaya College follows financial rules and regulations as lay down by the Chhattisgarh state Government. In all Government College the External Financial Audit is conducted occasionally by the Auditors from the office of Accountant General (AG) Raipur of Chhattisgarh Government. The Accounts Department of the College presents the supporting documents and appropriate explanations to queries, whenever necessary.

Principal of the College forwards all expenditure bills to the Account Section. Accountant cross-checks the proceeding bills, after being satisfied, all the payments are made by RTGS/ Bank Draft/Cheque. The Accountant of the College keeps all the purchase bills and documented in financial record. Finally Annual Income and Expenditure is duly certified by the Principal and Chartered Accountant (CA). The Account of Janbhagidari Samiti is also audited by registered CA.
